

We are pleased to announce that the DENR IX Regional Strategic Communication and Intiatives Group will be conducting the Regional Inter-High School Environmental Quiz dubbed as *Sukit Kinaiyahan* on October 16, 2024 in Zamboanga City. The exact venue will be announced at a later date.

Now on its 8th year, we extend our invitation to secondary and senior high schools in the region to participate in this esteemed competition. The event serves as a platform to promote environmental awareness, bringing together the Youth for Environment in Schools Organizations (YES-O) in the region.

In this connection, we would like to invite the following schools under your jurisdiction to join the above-mentioned activity, to wit;

- 1. Zamboanga del Norte National High School (Turno) Turno, Dipolog City
- 2. Punta National High School Punta, Dipolog City
- 3. Dipolog City National High School (Barra) Barra, Dipolog City

These schools are given priority. To secure a spot in the competition, the listed schools have until September 16, 2024, to confirm their attendance. In the event of non-confirmation, other non-YESO schools in the region will be considered. This year, we are limiting the number of participating schools to 25 on a first-come, first-serve basis.

Alongside, we will also be conducting the 2nd Regional Youth Summit. This will provide a platform for YES-O advisers and YES-O students-officers to exchange best practices towards environmental protection.

Each participating school may send four delegates, including one YES-O adviser, two student representatives (senior or junior), and one YES-O president.
