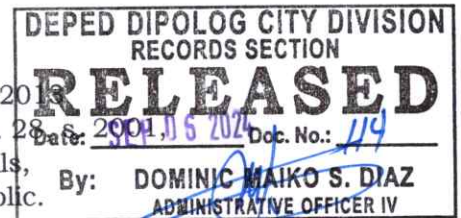

TOP 10 DIVISION LEVEL FINALISTS FOR THE ENVIRONMENTAL PROJECT PITCHING

With the issuance of Division Memorandum No. 358, s. 2024, the Learner Formation Unit and its partners have selected the Top 10 finalists for the Environmental Project Pitching, scheduled for Saturday, September 7, 2024. This advisory provides participants with key details about the activity.

Refer to Enclosure 1 for the final list of the Top 10 Division-Level Finalists.

The event will take place at the DepEd Dipolog Training Center, Miputak. Preliminaries will begin promptly at 8 a.m., and the pitching session will conclude once all finalists have presented their projects. Enclosure 1 also outlines the order of presentations.

Participants, including learners and advisers, are advised to wear simple business attire; there is no need to purchase a new outfit. If business attire is unavailable, the school uniform may be worn.

For the presentations, teams are encouraged to limit their slides to 10, as specified in the previous memorandum. Avoid overcrowding slides with text—focus on the key points of your project. It is recommended to print important details such as the budget breakdown, illustrations, and other key information. Distributing handouts during the session is encouraged, so teams should prepare at least three copies of their project. Each team is allotted a maximum of 10 minutes for their presentation. The participants in the project pitching will be the same individuals who attended the Environmental Leadership Summit.

Furthermore, all learner-participants are required to submit the parent/guardian's consent to their respective YES-O Teacher-Adviser. Please refer to Annex A for the template of the consent form.

The participation of learners and non-teaching personnel is in full compliance with the policy on off-campus activities as outlined in DO 66, s. 2017.
